Audit Report/Opinion for "National Hydrology Project Loan No. 8725-IN for the financial Year 2016-17 & 2017-18.

We have audited the accompanying financial statements of the World Bank Assisted "National Hydrology Project. (Department of Irrigation Government of Punjab) under the World Bank Loan No. 8725-IN, which comprise the statement of sources and applications of Funds and the Reconciliation of Claims to Total Applications of Funds for the year ended as on 31st March, 2017 and 31st March 2018.
